MOP-UP COUNSELLING

It is proposed to conduct Mop-up Counselling on 29.11.2025, Sharp 9:00AM at **Andhra Pradesh Fisheries University, Camp office, 5th Floor, Vishal Residency, Siddharth Engineering College, Padmaja Nagar, Tadigadapa, Vijayawada, Adhara Pradesh** to fill unfilled/vacant seats due to seat cancellation in BFSc course at College of Fishery Science, Muthukur/Narasapuram.

The guidelines for the Mop-up Counselling are as follows:-

- **All the candidates who had registered themselves for online counselling on APFU website for BFSc admissions for the year 2025-26 are eligible to participate in the Mop-up Counselling.**
- **If the admitted candidate cancels his/her seat after Seat allotment during Mop-Up admission process for the Academic Year 2025-26, the candidate forfeits the fees already paid and in addition, he/she has to pay an amount of Rs. 5000.00 towards Seat Cancellation fee for General and BC and Rs.2,500.00 for SC/ST/PH - Candidates.**
- They need not pay any additional fee to participate in the Mop-up Counselling but they need to **SUBMIT AN ONLINE UNDERTAKING** to participate in the Mop-up Counselling or any further rounds. The last date for the submission of the said online undertaking is **22.11.2025**.
- The Candidates who submitted the online undertaking only will be considered for the Mop-up Counselling and any subsequent rounds.
- The candidates who failed to submit the online undertaking are not eligible to participate in the Mop-up Counselling and they will be **automatically eliminated from the BFSc admission process from this point onwards**.
- Hence it is **mandatory** to submit the online undertaking on or before **22.11.2025** to remain in the BFSc admission process for 2025-26.

Instructions to Candidates

- Mop-up Counselling for admission into BFSc programme for the Academic Year 2025-26 is Scheduled on 29.11.2025 (Saturday) for available vacant seats.
- The Candidates who had submitted online undertaking for participating in mop-up counselling shall report at ANDHRA PRADESH FISHERIES UNIVERSITY, Vishal residency, Flat No-5B, opposite to VR Siddhartha Engineering College (Kanuru), Padmaja Nagar, Tadigadapa VIJAYAWADA – 521134 on 29.11.2025 (Saturday) between 9.00 AM to 10.00 AM along with all required certificates without fail.
- **The Mop Up notification shall be treated as an individual intimation, and no separate intimation will be issued. The Mop Up notification does not guarantee admission into the course to all those who have been called for.**
- If selected, you must pay the prescribed fee immediately as follows

- **Please note there is no hostel facility available at College of Fishery Science, Narasapuram.** (*Due to non-completion of permanent buildings, the college is likely to be temporarily relocated in any other suitable location within West Godavari District as per the availability of suitable infrastructure.)

- The candidates granted admission, should submit the following certificates in **Original at the time of admission itself**.
1. Pass Certificate-cum-Memorandum of Marks obtained by the candidates in the qualifying examination (Intermediate).
 2. Hall Ticket & Rank Card of AP EAPCET 2025.
 3. SSC or its equivalent Examination Certificate.
 4. The Community Certificate in the case of candidates belonging to Backward Classes/Scheduled Castes/Scheduled Tribes, signed by the competent authority/Latest EWS certificate for the year 2025-26 & older certificates will summarily be rejected.
 5. Bonafide or Study certificates (6th class to Intermediate or its equivalent).
 6. Residence Certificate, if applicable.
 7. Transfer Certificate from the College or School where the candidate last studied.
 8. Candidate joined under farmer quota must submit the Form I and Form II, with evidence of land owned: Adangal/ 1B (or) Copy of Original Pattadar Passbook.
 9. In case of candidates under Special Categories (CAP/NCC/PH/Sports & Games and Scouts & Guides) the original certificates issued by the competent authorities.
 10. Duly signed Undertaking Form.
- The Candidates who come after 10:00 AM will not be considered for seat allocation. For further details you may call 8985318321. Registrar, APFU.
- Since more number of candidates are called for this manual counselling for filling the vacant seats, it is likely that counselling process may extend to late in the evening. Hence the candidates and parents/guardians are requested to **come prepared for staying late**.
